

The major Conditions of eligibility for filling up of online application can be seen on www.minorityaffairs.gov.in and FAQs with regards to Time-Line/various activities relating to submission of application form on NSP homepage of the website i.e., www.scholarships.gov.in.

The eligible students may apply through online on the website of common National Scholarship portal of Govt. of India under URL www.scholarships.gov.in as per above given time line. It may also be ensured that the student will take printouts of the duly filled application forms and submit along with all supporting documents (i.e. residence proof, last class pass certificate, aadhar no., bank account in the name of applicant, income proof, minority certificate/affidavit) in their respective institutes. Institutes are suggested to verify the applications of the students on NSP portal using their Institute use ID AND Password, well in time.

Further, you are requested to fill up an online form on the National Scholarship Portal from your institute login and sent print out authenticated in duplicate along with credentials of the institute's scholarship nodal officer to this office at the earliest so that we will activate your institute/school account on the portal.
